


1. Final outcome of the notification order from MoUD, Govt. of India.

3. That the school shall comply with the provisions of section 10(1) read with rule 125 of DSEAR, 1973.
4. That the school shall observe all the provisions of RTE Act, 2009, DSEAR, 1973 and directions/instructions issued by the Department from time to time.
5. That the school shall submit the latest water test report issued by Delhi Jal Board within three months of the issuance of the letter of extension of recognition.
6. That the school shall get the permission from the Competent Authority to run pre-school and pre-primary classes within 03 months of the issuance of the letter of extension of recognition.
7. That the school shall comply with the orders dt. 07.11.2017/ guidelines of DoE and judicial pronouncement w.r.t. the safety of the students and shall take all necessary steps to this effect.
